Terms and Conditions

- All FACS scheme users must represent and play in a sport at a county team level or above.
- All FACS scheme users must be a resident of Mole Valley.
- Membership will be offered only for the sports, which are recognised by Sport England: <http://www.sportengland.org> (exceptions apply).
- The person whose name, photograph and card number are stated on the card may only use the FACS card.
- The FACS card is valid for one year. After one year, the FACS application can be renewed subject to eligibility.
- Facilities used should complement the sport specified in the FACS application.
- Facilities can only be used when they are available and FACS scheme users cannot book free facilities in advance.
- The FACS card must be produced every time the cardholder wants to claim a discount. Failure to do so will mean the full price will have to be paid.
- If the gym is to be used, age restrictions may apply and an induction must be completed and paid for.
- If you are applying to use Dorking Sports Centre, they will provide you with a membership card, valid for one year. Once you have received your membership card, you will no longer be required to take your FACS card.
- Applicants must produce evidence confirming their age, address and eligibility for the scheme.
- Proof of age can be provided by way of photo card provisional/full driving licence, passport or birth certificate
- Proof of address can be provided by way of a Council Tax bill, utility bill, bank statement or photo card provisional/full driving licence.
- Evidence of eligibility can be produced by letter from your Governing Body or Head Coach or an entry, which shows the FACS user's participation, such as a team sheet or a game report.
- Cardholders must inform MVDC immediately if there is any change to their name, address or eligibility for the card. If the change in circumstances means the cardholder is no longer eligible then their FACS card becomes invalid and must be returned to the Council offices in Pippbrook, Dorking.

- The information provided in the application form will be given to Dorking Sports Centre and/or Leatherhead Leisure Centre in order for them to issue a membership card. It will not be supplied to any other organisations.
- The facilities and activities covered by the FACS card scheme are subject to availability and may change or be withdrawn without notice at any time.
- MVDC reserves the right to terminate the FACS card should the cardholder breach any of the Complimentary Access scheme terms and conditions or should the facility manager give reasonable grounds to withdraw the benefit.
- MVDC reserves the right to amend and vary these terms and conditions at any time.

Those applying for/renewing a FACS card must:

- Complete an application form
- Submit a JPEG of a current small head and shoulders photograph of themselves
- Provide current evidence of their eligibility such as a supporting letter from their Governing Body or Head coach with their application or an entry, which shows the FACS user's participation, such as a team sheet or a game report.

Please allow up to 30 days for your card to be processed.

All applicants will be verified before a FACS card is issued. MVDC reserves the right to terminate membership should any breach of the FACS scheme conditions occur, or should the facility manager give reasonable grounds.
