Background

- 1.1. Each year the Council appoints representatives to outside organisations. When finalising its work programme for 2013/2014 the Scrutiny Committee agreed that it wished to review these appointments ensure sure that they were still relevant and offered value to the community
- 1.2. In late 2013/early 2014 a short questionnaire was sent to all outside organisations (apart from appointments connected with organisations such as Surrey County Council and the Local Government Association) seeking their opinion as to Mole Valley representation on their organisations. The information received was presented to the Committee at a meeting earlier in the year.
- 1.3 Following this the Strategic Management Team assessed the value to the Community of specific Member representation on these organisations. Their comments, as well as the original comments from the organisations themselves are set out in Appendix A.
- 1.4 A questionnaire was also sent to those Members who represent the Council on these organisations to establish whether the organisation was proactive in contacting our representative and what level of involvement was required. This information is also set out in Appendix A.
- 1.5 Representing the Council on these outside organisations is huge work commitment undertaken by Members and to get the maximum benefit of this commitment for all concerned, it would be appropriate for Mole Valley representatives on outside organisations to:
 - be briefed by officers before attending meetings of the organisations, where appropriate.

- provide feedback back to the Senior Officer responsible
- provide a report for Members and/or give an update at meetings of the Scrutiny Committee and the Executive from time to time.

1.6 A mechanism for this is being developed for inclusion with the Council's Constitution.

1.7 The Committee is asked to review the information and decide whether it wishes to make any recommendations on future appointments to the Council at this stage or whether it would wish to revisit the review at a later date when the process set out in Recommendation 3 has been embedded.
